#### 1. GOVERNMENT COLLEGE OF NURSING, KOTTAYAM


#### 1.1. History

Government College of Nursing, Kottayam was established in May 1982 as the third Government College of Nursing in Kerala. The college was started with four year B.Sc Nursing Degree course. The first batch of students were admitted on 31-1-1983. College functioned in the Medical College campus of Thiruvananthapuram from 1983 to 1985, as the physical facilities were inadequate at Kottayam. In November 1985, the college was shifted to Kottayam with three batches of students and started functioning in the old administrative block of Medical College, Kottayam. The new building for the college was inaugurated on 29-6-1997 by Shri. A.C. Shanmugha Das, the Honourable Minister for Health and Family Welfare.

General Nursing and Midwifery programme was started in 2000 under Tribal Sub Plan. Post Graduate Nursing programme was started in 2004. In 2011, Post Basic Diploma in Nursing programme was started in five specialties.

This college is recognised by Indian Nursing Council and Kerala Nurses and Midwives Council and is affiliated to Kerala University of Health Sciences.


College is recognised as PhD study Centre by MG University in the year 2011. In 2016 college is recognized as a Research center of Kerala University of Health Sciences, Thrissur.

#### 3.5 COURSE DESCRIPTION

#### A) BSc NURSING DEGREE COURSE (Affiliated to KUHS)

#### a) Admission

Application for admission to B.Sc. Nursing course can be registered only through online application. The provision for applying online is available at the website of www.lbscentre.kerala.gov.in

#### b) Eligibility Criteria/ Academic eligibility

The candidate should have passed Higher Secondary Examination conducted by Board of Higher Secondary Education, Kerala or Examination equivalent as approved by Kerala University of Health Sciences, Thrissur.

The candidate should have secured 50% marks in Physics, Chemistry, Biology and English put together.

#### c) Mode of selection

The Selection of students for the B.Sc. Nursing course shall be on merit basis, ensuring transperancy and fairness. The process shall be decided by the competent authority approved by the Government of Kerala and Kerala University of Health Sciences.

#### d) Medium of Instruction

The medium of instruction and examination shall be in English.

#### e) Internal Assesment.

Periodic written ongoing examinations are distributed throughout each semester (minimum 2 sessional examinations per semester for each course). Marks of assignments, seminars, projects, attendance etc will be added as continuous assessment to the internal marks (specific weightage is given) and an internal assessment for competency will be conducted in semester VIII.

#### f) Attendance and course period

a) Duration of the BSc Nursing course shall be four years (8 semesters including internship in the last semester). Clinical practice is given based on respective practical hours in each years.

- b) The candidate shall complete the stipulated course period as specified in the B.Sc Nursing course regulations to be eligible for the award of degree.
- c) Each candidate should put in a minimum of 80% of attendance of the prescribed hours in each subject in theory and in practical separately wherever applicable in each semester to appear for the university examination. However a candidate shall complete 100% attendance in practical before the award of degree.
- d) The Principal/Head of the institution shall submit attendance certificate for each students at the time of registration for examinations.

#### g) Condonation of shortage of attendance

The condonation of shortage of attendance of a candidate to a maximum of 10% for subject/subjects (theory or practical or both) can be granted once only during the entire course period. The Principal/Head of institutions are empowered to grant condonation for shortage of attendance on recommendation by the HOD under intimation to KUHS on genuine grounds only. A candidate must have to complete 80% of attendance in each of theory and practical wherever is applicable in order to be eligible in the university examination of the subject.

#### h) Leave, holiday etc.

As prescribed by Government/KUHS from time to time.

#### i) Transfer during course

Transfer to other institution within and outside the University under normal circumstances shall not be allowed during the course of study. However in exceptional cases within the University, the KUHS may apply discretion in this matter.

#### j) Duration permitted for completion of course

Duration of BSc Nursing course shall be four years, which is a credit and semester based program comprising of eight semesters including internship. The maximum period to complete the BSc Nursing course successfully shall not exceed twice the actual duration of the course (eight years).

#### **Examinations**

#### a) Schedule of Examinations

Examinations shall be conducted as per the schedule approved by the Board of Examinations, KUHS, Thrissur.

#### b) Scheme of Examinations

The scheme of Examinations shall be as per the regulations of the B.Sc Nursing course. For every subject, Theory and Practical shall be considered as a single block. If a candidate fails any one of them,he/she shall have to re-appear for the subject(theory and practical together).

#### c) Conditions under which candidates are permitted to proceed to the next higher class.

The candidate shall have cleared all the previous university examinations before appearing for university exams, at the end of seventh semester. However candidates shall be permitted to attend the consecutive semesters. The candidate should clear all the previous examinations before appearing for final semester (eighth semester) examination.

#### d) Criteria for pass

Candidate who has secured a minimum of 50% marks in theory (for internal and university examination separately) and 50% marks practical (for internal and university examination separately) in a subject shall be declared to have passed in that subject.

Candidate who has secured a minimum of 50% marks in aggregate in a subject/paper having more than one sections shall be declared to have passed in all the concerned sections of that subject/paper.

A minimum of 40% marks shall be the pass mark in internal/college examination for communicative English and elective modules.

A candidate failing in either theory or practical of a subject has to reappear for both theory and practical of that subject.

A candidate who passed all the subjects (including theory and practical) from semester I to semester VIII and completed 80% attendance in theory and 100% attendance in practical in each subject shall be declared to have passed the BSc Nursing course.

#### e) Carry over benefit

The candidate should clear all the previous examinations before appearing for final semester (eighth semester) examination.

#### f) Grading of performance

Based on the performance, each student shall be awarded a final grade at the end of the semester for each course/subject. UGC 10 point grading system is used with pass grade modified.

A semester grade point average (SGPA) shall be computed as weighted average of grade points obtained in all courses by the student during the semester excluding, Communicative English and elective modules. Cumulative grade point average (CGPA) shall be computed as weighted average of SGPA obtained in all semesters by the students during the course period. SGPA and CGPA are indicated in final grade in mark list/transcript showing grades of all 8 semesters and their courses/ subjects.

#### g) Declaration of class

- \* A first class with distinction is awarded to all candidates who scored a CGPA of 7.500 and above.
- \* A first class is awarded to all candidates who scored CGPA of 6.000 to 7.499 and above.

- \* A second class is awarded to all candidates who scored a CGPA of 5.000 to 5.999 and above.
- \* CGPA shall be reflected as failed for a student in case of failure, till he/she passed due subject.

First class/Distinction may be awarded irrespective of whether the candidate has appeared for regular/supplementary examination.

#### h) Declaration of rank

Ranks shall be awarded on the basis of final CGPA and aggregate of marks.

#### i) Internship

Internship is integrated as practice in the eighth semester of BSc Nursing programme. It includes intensive/practice/residency posting for 22 weeks (1056 hours) with 12 credits integrated in 5 specialty areas. A candidate should clear all previous examinations before appearing for seventh semester university examinations. However the candidate shall be permitted to attend the consecutive semester (internship).

#### j) Eligibility for award of degree

A candidate who passes entire subjects of the course will be eligible for the award of degree during the ensuing convocation. Degree is awarded by the concerned faculty of the university.

#### B) M.Sc. NURSING

(Affiliated to Kerala University of Health Sciences)

#### a. Admission

Annual admission for M.Sc(N) Programme should have prior sanction/permission from the Indian Nursing Council, Kerala Nurses and Midwives Council & University on the basis of Clinical facilities and teaching faculty.

## b. Eligibility Criteria/Admission Requirements:

- 1. The candidate should be a Registered Nurse and Registered Midwife with Kerala Nurses and Midwives Council.
- 2. The minimum educational requirements shall be the pass of regular degree course in Nursing(B.Sc Nursing/ B.Sc(Hons.). Nursing/Post Basic B.Sc. Nursing), with minimum of 55% aggregate marks, from an institution which is recognized by Indian Nursing Council.
- 3. Minimum one year of experience after Basic B.Sc.Nursing is required. One year compulsory nursing service/internship after successful completion of four year B.Sc Nursing can be considered as experience.
- 4. Minimum one year of experience prior or after regular Post Basic B.Sc Nursing will be considered.
- 5. Candidate shall be medically fit.
- 6. Relaxation of marks for SC/ST candidate may be given as per State Government norms.

#### c. Mode of selection to the course

The selection of students for the course shall be on merit based/ entrance examination ensuring transparency and fairness, the process shall be decided by the competent authority and as approved by the Government and Kerala University of Health Sciences.

## d. Medium of Instruction

The medium of instruction and examination shall be in English.

## e) Duration of the course

Duration of the course is two years

Weeks/year : 52 weeks

Leave : 3 weeks(20 days)

Examination : 2 weeks Total hours/week : 48 hours

48 hours x 47 weeks : 2256 hours/ year : 4512 hours **Total hours for 2 years** 

## f) Attendance and course period

- 1) Duration of the course is 2 years. The candidate shall successfully complete the stipulated course period as specified in the M.Sc Nursing course regulations, for award of Degree.
- 2) Candidate shall have 80% attendance of the prescribed hours in each subject for both theory and practicals separately wherever applicable, with minimum 50% of internal marks in each subject both in theory & practical. However 100% of attendance shall be completed for practical before the award of degree.
- 3) However, in case of subjects in which the instructional programme extend through more than one academic year and when there is no University examination in the subject for a particular year (i.e. non-exam going subjects), the attendance requirement shall not be less than 70% in Lectures and Practical/Clinical separately in the non-exam year. The Principal/Head of institution should ensure that the candidate has secured the minimum requirement of attendance in the non-exam going subjects before registering him/ her for the University examination.
- 4) The Principal/Head of the institution shall submit attendance certificate for each candidate at the time of registration for examinations.

5) The candidate shall possess good conduct during the course of study.

## g) Condonation of shortage of attendance

There is no provision for condonation of shortage of attendance for students of M.Sc Nursing programme. 80% attendance for both theory and practical separately are required for appearing University examination as per Statutory Council Regulations.

## h) Leave, Holidays

365 days are working days for PG students. They have to attend clinical duty for 8 hours daily.

- Candidates can avail 20 days of leave per year and not more than 10 days at a time. All students are eligible for weekly off of one day. Thus a candidate is eligible to avail a maximum of 73 days per year inclusive of 20 days leave and weekly off.
- Any leave over and above 73 days including maternity leave in a year will have to be compensated by adequate extension of the duration of the course.
- In Govt. Nursing Colleges, leave rules which are periodically revised/ amended as per the direction of Director of Medical Education from time to time shall be applicable to the course.

Examinations shall be conducted as per the schedule approved by the Board of Examinations, KUHS, Thrissur.

#### b. Scheme of Examinations

The Scheme of Examination shall be as per the regulations of the M.Sc Nursing course. For every subject, theory and practical shall be considered as a single subject, if a candidate fails in any one of them, he/she shall have to re-appear for the subject(theory and practical together).

## c. Thesis/Dissertation for the PG courses

Completed Synopsis shall be submitted to the University at the end of 9<sup>th</sup> month of the 1<sup>st</sup> year of the course through proper channel along with the prescribed fees. Thesis/ Disseration shall be submitted to the University at the end of 9<sup>th</sup> month of 2<sup>nd</sup> year. Evaluation of thesis/ Disseration shall be done as per the course regulations. The candidate shall be permitted to register for the final year examination only after the submission of dissertation.

## d. Conditions under which candidates are permitted to proceed to the next higher class

Candidates are permitted to proceed to the next higher class even if he/she is failed in a subject/subjects in the University examinations. However the candidate shall have to pass all the examination in the 1<sup>st</sup> year to appear for the 2<sup>nd</sup> year M.Sc Nursing examination.

## e. Criteria for pass

- \* Candidate who has secured a minimum of 50% marks in theory(for internal and university examination separately) and 50% marks in practical, (for internal and university examination separately) in any subjects, shall be declared to have passed in that subject. Candidate shall obtain minimum 50% marks for dissertation and viva.
- \* If a candidate fails in either theory or practical he/she has to appear for both theory and practical of the subject.

\* The candidate shall have passed all the examinations of 1<sup>st</sup> year to appear the 2<sup>nd</sup> year examination for M.Sc Nursing.

## f. Criteria for promotion

All candidates including candidate who fails in any subject/ subjects shall be permitted to continue the studies into the 2<sup>nd</sup> year. However, the candidate shall not be allowed to appear for 2<sup>nd</sup> year examination till such time that he/she passes all subjects of the 1<sup>st</sup> year M.Sc Nursing examination.

## g. Carry over benefit

- A candidate having 80% attendance in the theory and practical in all the subject and minimum required internal assessment marks are eligible for entry in to the next year.
- The student become eligible for writing the final examination only after passing all subjects of previous year.
- The maximum period to complete the course successfully shall not exceed double the duration of the course(four years).

## h. Declaration of class

First Class/ Distinction shall be awarded irrespective of whether the candidate has appeared for regular/supplementary examinations.

Below 50%	Fail
50% to below 60%	Pass with Second Class
60% to below 75%	Pass with First Class
75% and above	First Class with Distinction

#### i. Declaration of rank

- Ranks shall be on the basis of aggregate marks of all the University regular examinations of the M.Sc Nursing. Only those candidate who have passed all the examinations in the regular University examination and completed the course within the minimum prescribed course duration alone shall be considered for rank
- Total number of students registered in the final year examination shall be specified on the rank certificate.
- **j.** Attempt/Chance: If a student registers for an examination and attend none of the papers of the examination, that appearance shall not be considered as an attempt/ chance.

## k. Partial appearance in Examinations

Partial appearance is permitted in all the University examinations, provided the candidate satisfies 80% attendance in all subjects(theory and practical separately) of the respective examination, including the subjects in which the candidate is not appearing or eligible. Such candidate shall not be eligible for the award of rank.

## 1. Condonation of Break of Study

If a candidate is not attending the college for more than Six months, he/she on the recommendation of the Head of the Institution shall get permission from the University for re-joining with junior batch. The period of break of study thus condoned shall be excluded while calculating the maximum period prescribed for passing a course under the KUHS regulations. Condonation of Break of study shall be considered strictly as per the condition stipulated in the norms of the University.

## m. Eligibility for Award of Degree

A Candidate who passes entire subjects of the course shall be eligible for the award of Degree during the ensuing convocation. Degree is awarded by the concerned Faculty of the University.

## Eligibility for Admission to Examination

A candidate shall be eligible for the admission to the state Council / Board of Examination if the Principal of the school certify that:

- **a.** She / he has completed not less than eleven months of the course
- **b.** A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.

The diploma shall not be awarded to the candidate till she / he has completed the clinical / field requirements.

- c. A Candidate must secure 50% marks in internal assessment separately in each theory and practical.
- **d.** The record of practical experience is complete. (The Principal shall send to the Council / Board, the internal assessment for each subject, i.e. both theory and practical (S) before the start of the examination along with the examination form).

## **GRADING OF EXAMINATION**

Examination shall be graded on aggregate marks of the entire three years of the training programme, as follows:

- 80% and above Distinction - 70% to 79% First Division - 60% to 69% Second Division Pass - 50% to 59%

## D) POST BASIC DIPLOMA IN SPECIALTY NURSING

The examination to be conducted by the State Nursing Registration Council / State Nursing Exam Board.

#### **GRADING OF EXAMINATION**

In order to pass, a candidate should obtain at least 50% marks separately in internal assessment and external examination in each of the theory and practical examination.

students will be given opportunity of maximum three attempts in examination for passing

## 3.6 SCHOLARSHIPS AND STIPENDS

Various **scholarships** are available for students based on merit and income

1. e -Grantz scholarship for SC/ST/OEC/OBC(H) students

Students belonging to these communities are eligible for this scholarship irrespective of annual income. Yearly Lump sum grant (LSG) for BSc Nursing students is 1200 Rs for SC/ST Category and 1000 Rs for OEC and OBC(H). Post Basic /MSc Nursing students will get 1900 Rs and GNM students will get 1600 Rs.

Additionally Pocket money of 200 Rs monthly will be provided

ABLC (Mess bill) of maximum 3500 Rs per month

2. Scholarships (e-grantz) is given to SEBC & forward caste students.

SEBC & forward caste category students whose parent's annual income is less than Rs. 1,00,000/-( one Lakh) can apply for the scholarship. The details are available at www.e-grantz.kerala.gov.in

3. Merit Cum Means Scholarship (MCMS) for all the minority community students whose parent's income is less than 2.5 lakhs per year. The details are available at www.momascholarship.gov.in

#### **Stipends:**

M.Sc Nursing students are eligible for stipend of Rs.17,500/ per month on executing a bond to the effect that they would serve the Government for a period of one year after the completion of the course if Govt. requires. Post Basic Diploma in Specialty Nursing students are eligible for stipend of Rs. 7,000 per month.

## 4. DISCIPLINE AND RULES

#### 4.1 General Rules:

- Working hours: The class and clinical hours are from 8am to 5pm for all students except M.Sc Nursing students, whose duty hours are from 7.30am to 7.30pm. The college office functions from 10am to 5pm.
- Students are required to observe order and silence at all times in the college especially during working hours.
- Students are forbidden to address higher authorities or Government directly. Communication intended for higher authorities must be submitted through Principal, which will be forwarded if she/he considers it desirable.
- Students are forbidden to take any active part in political agitation against the authority or the Government. Students are prohibited from organizing any meeting or entertainment activities in the college or collecting money without the permission of the authority.
- Students are not permitted to go to other colleges to take part in acts of indiscipline such as organizing demonstrations/strikes etc.
- Students are forbidden from affixing posters, displaying material and other articles on the walls of the college building and its premises without prior permission.
- Mobile phones are prohibited in the College Campus.
- Students should wear identity card in the Campus.

## 4.2 Rules related to attendance and leave

- Students should be punctual for theory classes, practical sessions and clinical duties.
- Students are expected to be present in the classroom, five minutes before the beginning of classes.
- No students shall be absent from class unless such absence is satisfactorily reported.
- Leave application should be submitted to the Principal through Class teacher before availing the leave and should state clearly the ground for the leave, number of days and the dates for which leave is required.
- If unavoidable circumstances occurs it should be intimated to class teacher through telephone.

## 4.3 Library rules:

- Library will be kept open from 10am to 5pm on all working days.
- Library is for the use of the students and staff of this college.
- Personal belongings and lab coats will not be permitted inside the library.
- Books are issued to the students for a period of 14 days.
- Each student is permitted to take three books at a time.
- A fine of Rs.1/- per day will be collected for late returning of books.
- Identity card is compulsory for getting access to the library.
- Complete silence must be maintained in and near the library.
- Students should not bring mobile phone or any electronic instruments inside the library.
- Enter your name and sign in the register kept at the entrance counter before entering library.

- Readers are not allowed to bring their personal books or any printed materials inside the library.
- Readers should not talk or discuss as they may disturb other readers. Reading hall is meant for individual study and research only.
- If the book is lost or damaged by the student or if the pages are missing from the books, the borrower will be required to replace the book with a new copy or pay triple the cost of the book.
- Before borrowing the books, library members must check the books properly and if any damage is identified should be reported to librarian/library staff.
- Computers in the library should be used for academic only.
- Reference books, thesis works, journals and examination question papers will not be lent out.
- Photocopying facility available in the Library is only for journal articles
- The librarian may call back any book from any members at any time and the member shall return the same immediately

### 4.4 Hostel Rules:

The ladies hostel is located in the college compound about hundred meters away from the college of nursing. The ladies hostel is a three storied building which provides accommodation for about 300 students of both B.Sc nursing and General nursing programme.

The Principal of College of Nursing is the warden of the hostel. Hostel is under the control of Principal and managed by Asst .warden who is assisted by a team consisting of housekeepers, cleaners, and watchman.

The inmates of the hostel should strictly follow the rules and

regulations of the hostel. If they violate the rules they shall be removed from the hostel by the authorities concerned. There is a hostel management committee which consists of Principal(warden), Assistant warden, Professors, Housekeepers, Hostel secretary, Mess secretary and two representatives of each classes (BSc Nursing, GNM). The committee shall meet once in three months. The general body meeting will be conducted as and when necessary and should be attended by all inmates.

## A. ADMISSION

Those who seek admission should submit the application in the prescribed form

Duly filled application in duplicate signed by the student and parent has to be submitted to the principal. One form will be kept in the college office and the other one in the hostel.

On admission students should pay Rs.1250 as mess advance (refundable ) and Rs. 250 as Mess deposit and Rs.500 as hostel establishment fees which may be subject to change from time to time. It will be utilized for the maintenance of the hostel.

Rooms will be allotted at the discretion of the Warden /Asst .Warden based on the seniority of applicant and distance from home. Within ten days of allotment room has to be occupied by the students otherwise the admission will be cancelled. Each room accommodates 2-3 students. students will be shuffled as and when required .

## **B. GENERAL RULES FOR INMATES**

All residents must maintain standards of behavior expected of students of a prestigious institution. They are expected to behave courteously and fairly with every one both inside and outside the campus. Students are forbidden from making any personal dealings with the cleaners/ part time sweepers / security personnel or other hostel employees.

The inmates have to strictly follow rules of modesty and decorum in dress in the hostel.

- \* All residents are required to carry their identity card issued by the college with them
- \* Students shall not participate in any anti-national, anti-social activities inside or outside the hostel campus.
- \* Students are expected to keep their belongings like jewelry, costly items, money etc under safe custody and at their own risk.
- \* Complete silence to be observed during study time and night rest. All students should sleep in the rooms allotted to them.
- \* Do not indulge in any activities which interfere with the learning of students like reading aloud, singing loudly, keeping music loud etc. Do not use abusive language.
- \* Do not play games inside the room or in the corridor of the hostel.
- \* Do not conduct parties of any kind inside the room or in the corridor. Meetings of any kind has to be conducted in the dining room or in hostel premises after getting prior permission from the warden or Asst. warden. Creating groups based on religion, caste and language is strictly prohibited in the hostel. Participation in political meetings, propagandas and processions are strictly prohibited. Any students indulging in these activities will be expelled from the hostel
- \* Residents should not keep and use television or other gadgets like blue tooth speaker in hostel rooms or in common places inside the hostel.
- \* Students can watch TV in the common TV room provided in the hostel.
- \* Students should not download, view and share copy righted cinemas and videos using their laptops/ mobile phones in side the hostel. Violations of rules in this regard will be considered serious and disciplinary actions will be taken
- \* Do not use own vehicles in the campus.
- \* Pets are not allowed in the hostel. Do not give food to stray dogs and cats in hostel premises

- \* Students must vacate the rooms after the completion of their course with proper intimation to the office. Students should not vacate the hostel without the knowledge of the authorities concerned (House keeper and Asst. warden/Warden) All dues should be remitted to obtain no dues certificate from the hostel. If any student desires to get admission to hostel again should get the prior permission from the warden.
- \* Students suspended from the college as part of disciplinary procedures will be expelled from the hostel.
- \* Day scholars are allowed to enter the hostel only after obtaining permission from authorities

## C. INSTRUCTIONS REGARDING ROOM MAINTE-NANCE AND CARE

- \* The rooms, common areas and surroundings should be kept neat and tidy. Discarded materials and papers should not be thrown out in rooms, terrace and premises. The rooms, doors etc should not be disfigured by writing, sticking posters etc.
- \* Avoid wasting of water and electricity. Ensure that the taps are closed properly after use . Switch off fans and lights when not in use.
- \* Keep toilet and bathrooms neat. Students should dispose the waste safely in the container provided for the purpose.

Leakage of water in the bath/rest rooms and tanks should be immediately reported to the house keeper

- \* The news papers and other magazines should not be taken from the reading area to the rooms for reading.
- \* Cooking is not allowed in the rooms. A stove is provided in the mess hall for heating water.
- \* Clothes should be dried only in the drying place.
- \* The inmates are not allowed to use any additional furniture or equipments without permission.
- \* Inmates are not allowed to move any furniture or fittings from one room to another.

- \* Electric fittings/personal furniture should not be used without permission.
- \* Anybody destroying the hostel property will be fined or punished. There is separate prayer rooms for students belong to all religions
- \* Inmates are not permitted to conduct any meeting in the hostel without the permission of the Asst warden/Warden.
- \* All intimations should be done through Asst warden

#### D. HOSTEL TIMING

All inmates are expected to be in the hostel by 6.30 pm, unless they have obtained a late pass for the same in writing from the Asst. warden.

Day and night roll register is maintained .House keeper / Hostel secretary is authorized to take roll call.

In the morning hours, inmates are expected to be in uniform for roll call 15 min prior to duty time

Time for roll call is 7.30 am - 7.45 am in the morning. The first bell at 7.30 am, second bell at 7.40 am for English news paper reading /birthday wishing and third bell at 7.45am for leaving the hostel for the duty.

The late comers should enter their names in the register and it will be reported to the principal.

Night roll call at 7 pm -7.30 pm in the evening. Inmates should be physically present for roll call

8 pm -11 pm is the compulsory study time, silence to be maintained during study time.

If any inmates found to be missing, the matter has to be reported to the warden /Asst warden immediately

Any student found in outside campus areas at late night times, out of bound areas are liable to be questioned / checked by the civil and police authorities and the institute /hostel authorities will not be responsible for any such action taken against such student for violation of any law and order.

#### E. OUT PASS FOR STUDENTS

A separate out pass book is maintained in the hostel. Students are allowed to avail outpass any day of the week from 4pm to 6.30 pm. Students have to write in the outpassbook the time of leaving and returning to hostel. For out pass seeking students, they are not permitted to go alone and no out pass is sanctioned after 6.30 pm. Special sanction is to be obtained by the students when they need to attend any programme after 6.30 pm.

Written permission to be obtained from the warden or asst warden for attending any functions or programmes during holidays. Students are not allowed to go out wearing uniform.

Student who are living in the hostel and who wish to stay with their sick parents in the Medical College hospital should personally get permission from the warden /Asst warden if it is really needed. Under any circumstances they should not leave the hostel before they are permitted to do so by the warden or Asst warden.

## F. HOME PASS FOR BSC STUDENTS

For getting home pass the students have to write in the register meant for this and house keeper countersigns the request. On returning to hostel, students should enter the time and put signature in the register. Special permission has to be obtained from class coordinator / Asst. Warden / Warden for going home during other holidays and occasions.

Home pass is allowed on 2<sup>nd</sup> Saturdays of every month. They can leave the hostel on Friday evening and should come on Sunday evening. No students are permitted to go home if they did not write in the home pass register in time. The students who cancelled home pass after writing in the home pass register should inform housekeeper in time.

No students are permitted to go to other students home without the permission of their parents and warden /Asst warden.

The students do not come back to hostel in time, their parents should inform the matter to the house keeper and they should meet their class coordinator /Asst warden before entering the hostel. The students who want to go home urgently (death of a close relative or in any other emergency) may get permission from Warden/ Asst warden after duly informing to the class coordinator .Students are allowed to go home with parents or any other relative authorized by parent in case of emergency.

First year students are allowed to go with their parents only, during initial times and parents have to take special permission if they have to be send alone or with other students.

#### FOR GNM STUDENTS

Since GNM students are having one month vacation, they are permitted to go home as per the days of vacation allotted to them and during National and religious holidays. Permission will be granted as per the recommendation of the class coordinator.

First year students are allowed to go with their parents only and parents have to give special permission letters if they have to be sent alone or with other students.

## G. HOSTEL MESS

The mess is run on contract basis at the rate of Rs 100/per day which will be subjected to change as needed. Hostel mess is compulsory for students. Food via online delivery is banned in the hostel.

Do not waste food

Follow the mess timings written in the notice board The inmates are not expected to take food from the dining hall to their rooms. Food can be taken to room for sick students after informing house keeper

(Considering covid circumstances students are now allowed to take food to their rooms and have it in room rather than eating in the mess hall.)

If there is any complaint regarding mess it should be brought to the notice of the warden or Asst warden.

Inmates are not expected to enter the kitchen and give direction to the kitchen staff.

Students should have their own plate and glass to take meals. Students should tie up their hair and should be in modest dress while entering mess hall.

They should maintain a queue for getting meals and keep silence in the mess hall.

Those who want veg/non veg should inform the mess secretary in advance and avoid wasting of food.

Put the plate and glass in the plate rack after washing.

All the students should leave the mess hall at 7.30 am in the morning and 8.00 pm in the evening.

## H. RECREATION FACILITY

Students are provided with recreational facility like caroms and television kept in the dinning hall.

Students can watch television during the day time on holidays without causing disturbance to others.

Outdoor games: there is facility for outdoor games in the hostel campus or in the playground constructed near College annexe.

#### I. SICKNESS REPORTING

If any one falls sick it should be immediately reported to the house keeper.Students should enter her name in the register kept for that purpose.The house keeper will inform the matter to the Asst .warden

Student can approach house keeper /Asst.warden/class coordinator to get the medical help.

If the students get sick in the college, house keeper or Asst.warden/Class co ordinator may be informed and they will

arrange senior students to accompany the sick student to medical college hospital and get the treatment.

The student may take rest in the sick room till recovery. Food may be given in the room, if needed.

If students falls sick and remain in the hostel they should submit the leave letter forwarded by the house keeper to the class coordinator

The parents /guardian will be informed if students get admitted in the hospital and parents should take care of their children while in the hospital.

## J. FACILITIES FOR MAKING PHONE CALLS

Students are allowed to use their mobile phones in the hostel.

If they have to make urgent phone calls they can also use hostel mobile phone.

They are not allowed to keep mobile phones with them while going to classroom and clinical areas.

Students are allowed to take mobile phones if they are going to hospital for treatment

Class representatives are allowed to take mobile phones with the permission from the class coordinator to arrange external classes or for project purpose.

#### K. STUDY TIME

Students can utilize the central courtyard which is now converted in to study hall ,own rooms, ,front veranda of every floor for study purpose.

They should keep strict silence during study timings.

Students have to complete daily assignments and study the daily

Students have to keep the doors of their rooms opened if they are studying in their rooms during 8.00 pm-11.00 pm.

Asst .warden or house keeper may randomly supervise the students during their study timings

During study time no one is allowed to indulge in other activities.

#### L. HOSTEL FEES

All the students should pay the rent, establishment fee and electricity charge ,mess fee etc before **fifth of every month**. Fine will be collected for late payment.

All inmates have to pay an amount of Rs 300/ as an establishment charge and the amount is subjected to change as and when needed. Electricity charges are to be paid every month as per bill (total amount divided by the number of inmates)

The room rent for students is Rs 50/- per month and it is to be paid in the college office before 10<sup>th</sup> day of every month.Day scholars can stay in the hostel on emergency situations on payment of Rs 15+Mess fee.

Mess fee (Rs 100/-day) for the month (which is subjected to change as needed) are to be paid before 5<sup>th</sup> of every month.

## M. VISITORS

The house keeper will prepare the list of visitors who are authorized by parents at the time of admission to the hostel. Visitors belong to the list are only allowed to visit the students.

Visitors are allowed between 9 am -6 pm on Sundays and all holidays. Visitors are permitted only in the place provide for the purpose .Every visitor shall make the following entries in the book provided for that purpose name of the visitors, address, relationship with the student and his/her sign.

Maximum time allowed for each visitor is only 45 min.

Parents, relatives and alumni are not allowed to go to the room of students.

The students are not allowed to spend time with the parents or relatives of other students.

#### N. USE OF VISITORS ROOM

There is a visitor's room which is built in front of the hostel. It is mainly for use of mothers coming from far away. It is mainly for toilet facility and for having food they brought from home.

Those who use the visitors room for night stay in case of sickness of students, should enter the details in the visitors register. Student's female relatives are only allowed to stay in the visitor's room. Students should get prior permission from the house keeper by writing a request. The visitors room to be kept neat and tidy after the use and the keys to be handed over to the house keeper immediately.

Students are not allowed to take food from the mess to their parents.

#### O. HOSTEL EXECUTIVE COMMITTEE

There is a hostel executive committee consists of hostel secretary, mess secretary, mess and hostel representative from all batches.

They are also responsible for the hostel maintenance ,cleanliness of the hostel and discipline of the hostel. Monthly meeting is held to discuss any issue and problems.

Repairs in the rooms or any replacement are to be written in the complaint book and to be informed in time to house keeper.

#### P. ANTI RAGGING MEASURES

Ragging in any form inside or out side the hostel is considered as a criminal offence and if anyone found indulging in ragging, the matter will be reported to the police and students shall be expelled from the hostel.

As per legal perspective ragging is a criminal and non-bailable offence. Display of noisy disorderly conduct, doing any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear, shame or embarrassment to a student including teasing, abusing, playing practical jokes on or causing hurt to such student or asking the students to do any act or perform something which such student will not in ordinary course be willing to do, will be treated as ragging

There is an anti ragging committee which takes precautions to prevent any sort of ragging issues. The first year students are specially protected from any sort of harassments .Special timing are given to students for mess . They are accompanied by house keeper when they are coming and going from college. They are not allowed to interact with senior students in the first three months. The delegated members from anti ragging committee visits hostel for the first three months to make sure that there are no ragging issues.

## Q. COMPLAINTS AND REPRESENTATIONS

Suggestion box is kept in the hostel. Students can write and drop their suggestions or complaints regarding quality of services and facilities provided in the hostel in the box. Anonymous letters may not be considered. Students can mail (grcgcnk@gmail.com) their grievances through the email ID

Parents can enter suggestions in the suggestion book maintained at the hostel.

## R. DISCIPLINARY ACTION

The rules and regulations are formulated for the safety and benefit of the inmates and for the effective management of the hostel The warden / hostel monitoring and maintenance committee members may enter any room for inspection at any time of the day or night

Disciplinary action will be taken if any inmates violates the rules and regulations depending on the gravity of the act. The forms of punishment can be as follows:

Written apology, Fine, Suspension and Expulsion from the hostel - The warden will have the right to refuse admission to /expel any applicant without assigning any reason or for gross violation of rules or misconduct by the student

## vii) Global Fund for AIDS, Tuberculosis and Malaria (GFATM) Project

The project was started in India in 2008 supported by WHO and Indian Nursing Council. This college was a training centre of GFATM from 2009 onwards. This project aimed at strengthening and capacity building of 55 nursing training institutes and training of 90,000 nurses in India on HIV/AIDS and ART within a period of five years (2008-2013). Later GFATM Project was extended till March 2015 focused on training of Nurses and ANM on HIV/AIDs and Tuberculosis.

Govt. College of Nursing, Kottayam was a recipient of this project and organized training programmes for staff nurses and ANM regarding HIV/ AIDS and Tuberculosis from the four districts of Kerala namely, Kottayam, Thrissur, Ernakulam and Idukki and trained more than six thousand nurses of Govt and Private sector.

## **Nurses and People:**

- The Nurse, in providing care, promotes an environment in which the values, customs and spiritual beliefs of the individual are respected.
- The Nurse holds in confidence personal information and uses judgement in sharing this information.

#### **Nurses and Practice:**

- The Nurse carries personal responsibility for Nursing practice and for maintaining competence by continual learning.
- The Nurse. Maintains the highest standards of Nursing care possible within the reality of a specific situation.
- The Nurse use judgement in relation to individual competence when accepting and delegating responsibilities.
- The Nurse when acting in a professional capacity should at all times maintains standards of personal conduct which reflect credit upon the profession.
